**SOCIAL INTERVENTION THROUGH STUDENT UPLIFTMENT**

**ABSTRACT:**

Here we would like to explain the initiation of two Trusts in the year 2021 by our social work students who were inspired by Social work curriculum and motivated by Department Staff. The names of these Trusts were Kalasam Trust and GUYAS Trust which were registered under Indian Trusts Act 1882. The focus groups for GUYAS are Youth and Adolescents and Kalasam Trust works for needy people in common.

**Key Aspects:**

The Students namely, Mr. B. Balavishnu, Ms. M.V. Shruthika, Ms.A.Yogapreetha and Mr.Periyasamy, who were studying II BSW and Mr. D. Ajay Kumar and Ms.Chandralekha were studying III BSW in the year 2021 in Mannar Thirumalai Naicker College. They were bright, self- motivated students and actively participated in the Departmental and Extension Activities. In the course curriculum, they studied about the procedure for registration of welfare organisations and the role of these organisations in the welfare of the people. This inspired them to render their service in a structured way. With this inspiration, they contacted the Department Staff for guidance and proceeded to start their own organization namely, the Kalasam Trust and GUYAS Trust and formally registered under The Indian Trust Act 1882.

From that time onwards, these two organisations were doing social service to people in terms of:

- Providing free meals to people living on streets on regular intervals,
- Providing food and water to animals along hill sides during Corona Pandemic Period,
- Providing relief materials to people affected by Flood and Cyclone in tamilnadu,
- Organising Awareness Programmes on Road Safety and
- Awareness about Tuberculosis among School Children in the form of Street Plays and awareness songs.

At present, Mr. Ajay and Ms. Chandralekha have completed their Master degrees and got their placement at Claretian Mercy Home, a Child Care and Adoption Centre , Madurai and still continues their service as and when time permits. Mr. BalaVishnu, Mr.Periya samy, Ms. Yogapreetha and Ms. Shruthika are pursuing their Master Degrees in the same Department and continue their services based on their financial availability and time.
