
ACTION TAKEN REPORT



A meeting was convened on 17.08.2023. The following decisions were taken:-

2. As per the directions of the Directorate of College Education, Chennai (Letter No 34200/M3/2023 dated 08 September 2023) Mannar Thirumalai Naicker College, Madurai, Anti-ragging and Anti Social Activity Committee has discussed with college students on 15 September 2023 regarding creation of differences free society or caste/creed in schools and colleges. The following opinions are received from the students to the government.
 - (a) Caste/creed based discrimination is very popular in rural area and its nearby school/colleges. So government should concentrate more on these areas regularly.
 - (b) Community certificate should not be a mandatory by college/schools during joining or after joining of the classes.
 - (c) School admission should be in marks/merit based or entrance examination based but should not be caste/creed or communal based.
 - (d) School/college name should not be christened after the name of any community based leaders.
 - (h) During the announcement of the Scholarship related forms submission, student should only be called through separate messages not in open manner in classroom. It creates a big discrimination in friend circle.
 - (j) Community/religion based symbol based wearing dress/sign should be avoided during college/school education.
 - (k) Higher castes/rich students wear the high quality of dresses. So, this is not affordable by the students of the under privileged. Uniform dress is to be implemented in colleges also by practiced in schools.
3. Anti ragging complaint box was opened on 12.08.2023, 18.08.2023, 24.08.2023, 01.09.2023, 08.09.2023, and 15.09.2023 in the presence of the committee members and "Not found" any complains/ grievances in all the dates.






